I. Call to Order

The meeting was called to order by Chairman Dorsey Powell at 7:02 PM.

II. ADMINISTRATION

The minutes of the November 5, 2015 meeting were presented for approval. Trustee Ed Hogan made the motion to accept the minutes as presented. Trustee Jeffrey Carlson seconded said motion. **The OFPD Board approved with no opposition.**
